## **About the Speaker**

Marielena Hincapié is a nationally respected legal and political strategist in the social justice movement, and a leading voice in the national conversation on immigration. Currently the Distinguished Immigration Scholar at Cornell University, Marielena is the former executive director of the National Immigration Law Center (NILC) and the NILC Immigrant Justice Fund (IJF). She is a key figure in immigration policy, leading transformative initiatives such as DACA and the #ImmigrantsAreEssential campaign. An immigrant from Colombia, Marielena brings a bilingual and bicultural perspective to her work. Marielena has been recognized with numerous awards, including Univision's Corazón Award, UnidosUS and the Cesar E. Chavez Community Service Award by the US Hispanic Leadership Institute.



## **About the Justice Forum**

Pisgah Legal's Justice Forum will be held at the Thomas Wolfe Auditorium in downtown Asheville on Thursday, October 10th.
